

Patriot Feed Giveaway Official Rules

1. Introduction: Equine Network, LLC (d/b/a *Horse&Rider* ("Sponsor")) is offering the Patriot Feed Giveaway ("Contest"). NO PURCHASE NECESSARY. A PURCHASE DOES NOT IMPROVE YOUR CHANCE OF WINNING. VOID WHERE PROHIBITED.

2. Eligibility: Entrant must be eighteen (18) years of age or older as of September 1, 2023 (or age of majority in state of residence) and a resident of the following states: Alabama, Arkansas, Florida, Georgia, Illinois, Indiana, Iowa, Kansas, Kentucky, Louisiana, Maryland, New Mexico, Michigan, Minnesota, Missouri, Nebraska, New Jersey, Ohio, Oklahoma, Pennsylvania, South Carolina, Tennessee, Texas, Virginia, Wisconsin. Limit one [1] entry via an official entry form per participant. All required information/fields must be fully, accurately, and legibly completed or entry may be voided. Contestants may enter once (1 time per person) during the Contest period. More than one (1) entry from any person or email address during the Contest period will void all entries from that person or email address.
